Purchase Price

Purchase price of this puppy will be \$_____, less the non-refundable* deposit of \$_____. The deposit can be paid via CashApp, Paypal, or Venmo. The balance in full is due at the time of pick up or prior to shipping. Final payment is due in **CASH** at pickup. Electronic payment will be accepted for puppies that are shipping as final payment is due prior to them leaving our home.

*The deposit is refunded in full should something happen to the puppy before pickup/shipping age. Deposits will NOT be refunded if buyer(s) decides not to continue with the purchase of the puppy at any point after deposit is made. Reserved puppies must be picked up by 9 weeks of age. If arrangements need to be made to leave the puppy with breeder beyond the age of 9 weeks there will be a charge for boarding & those fees must be paid in advance. If puppy is not picked up by 9 weeks & prior arrangements for boarding have not been made the deposit is forfeited.

Shipping

Shipping is available for our puppies. We prefer to ship with a flight nanny but this can only be done for puppies that still fit under the seats in the airplane cabin. Seller will get the puppy's health certificate if needed in time for the flight & will work with the buyer & nanny to get the puppy to the airport. We prefer to work with TLC Flight Nannies but will work with whoever the buyer arranges the flight with as long as the puppy is flying out of Tulsa International Airport. Arranging the flight & payment to the flight nanny is the responsibility of the buyer. Ground shipping is an option for older pups but all

arrangements for this plus payment to shipping company will be the responsibility of the buyer.

General Agreement

Breeder is selling the puppy outright. Breeder will provide the buyer with AKC Limited Registration papers when the puppy is picked up or shipped.

This agreement guarantees that the above puppy is in good health at the time of sale. The puppy has been immunized & wormed accordingly and appears free of communicable disease. A licensed veterinarian has examined the puppy. It is recommended that the buyer take the puppy to their veterinarian within 72 hours of receipt for a physical exam.

All puppies are microchipped prior to leaving the Breeder's home. We ask that you leave our phone number as a backup on the microchip registration for the life of the pet. We keep AKC records for every puppy & know where every one belongs. If the dog is separated from the buyer for any reason & buyer cannot be reached for more than 24 hours then we will retrieve the dog & hold them until you can be located. Distance is not an issue, we will find a way to get to them if needed to ensure they end up either back with their family or back with us.

In the event that the buyer becomes unable to care for the puppy/dog, or just decides that he/she does not want the puppy/dog they **MUST** contact the Breeder first. We will **ALWAYS** take the puppy/dog back, no matter what the situation or the age of the dog. No refund will be given to the buyer. Breeder may also either ok the sale of the puppy/dog to another individual or assist with placing the puppy/dog in a suitable home. The puppy/dog is **NEVER** to be turned over to an animal shelter or rescue group. This helps Breeder assure that the puppy/dog is never in a situation where it is homeless or lost in a rescue/shelter environment.

Health Guarantee

This puppy/dog is guaranteed until 1 year of age against fatal and life altering congenital disease which adversely affects the health of the animal. This guarantee includes congenital kidney, heart, pancreas, and liver problems of a severe life threatening or altering nature. Minor health problems that can be cured by medication or surgery are not covered by this guarantee. If the dog should pass away within this one-year time frame, the Buyer must pay to have a full necropsy to ascertain cause of death. If reason is congenital, the Breeder will replace the puppy/dog. All items covered under this guarantee are by replacement only. Breeder must be notified of the congenital defect within 2 business days of the licensed veterinarian's diagnosis and have one (1) report from an unassociated veterinarian documenting the same problem. This veterinary documentation must be provided to the Breeder & the puppy/dog with the defect must be returned to the Breeder in good condition (unless other arrangements are agreed upon or the dog was euthanized with the prior permission of the Breeder, at the Buyer's expense, to qualify for a replacement puppy). Breeder will provide a replacement puppy of equivalent value as soon as one becomes available. No Refund, in part or full will be given, no exceptions.

Breeder will not be responsible for any medical expenses incurred. A puppy/dog showing any serious genetic or congenital defect will be replaced as follows: Replacement puppy must be mutually agreed upon and will be of comparable quality. It is understood that the replacement puppy may not be from the exact same parents as

original puppy and if the buyer chooses a puppy of higher quality they will be responsible for payment for the difference. Replacement puppy will be given to the buyer as soon as one becomes available.

If by chance the buyer does not find a suitable replacement from the next litter, they have the option to wait until another litter. The Buyer will be responsible for all transportation costs of the replacement puppy.

This guarantee **does not** include the following: injuries, fleas, mites, ticks, umbilical or inguinal hernia, demodectic mange, cherry eye, entropion, undescended testicles, kennel cough, canine influenza, coccidia, giardia, heartworm, scabies, autoimmune disorders, allergies or any other parasitic agent.

We, the breeder will also not be responsible for Parvo, Distemper, Kennel Cough, Canine Influenza, or Coronavirus after 48 hours from the time of sale, as these are highly contagious diseases and they can be contracted immediately after leaving our property.

Grade 1 and Grade 2 heart murmurs are not included in this guarantee. Low grade murmurs can be physiologic in nature & often puppies will outgrow these murmurs by a few months of age.

This guarantee is void if the said dog is a female and has been bred. This contract is for limited registration & no breeding rights, breeding voids the agreement.

Roper's Boxers is not responsible for any accidents that may happen to the puppy/dog after it leaves their property.

This guarantee applies to the original Buyer and is non-transferable to third parties.
