Deposits may be paid via CashApp, PayPal, or Venmo. Remaining balance is due in full at pickup or prior to shipping.

Final payment for in-person pickup must be CASH. Shipped puppies must be paid in full prior to leaving Breeder's care.

### **Deposit Policy:**

- Deposit will be refunded if something happens to the puppy prior to pickup/shipping age.
- Deposit is forfeited if Buyer chooses not to complete the purchase.
- Puppy must be picked up by 9 weeks of age unless prior boarding arrangements are made and paid in advance.

### **3. PICKUP & SHIPPING OPTIONS**

**Pickup:** All in-person puppy pickups take place at the **Breeder's home**, unless otherwise agreed to in advance. Buyers may also choose to fly into **Tulsa International Airport (TUL)** to personally pick up their puppy, and the Breeder will make reasonable efforts to meet the Buyer at the airport for pickup.

**Reserved puppies must be picked up by nine (9) weeks of age**, unless prior arrangements have been made and agreed to by the Breeder. Additional boarding fees may apply for puppies held beyond nine (9) weeks of age.

**Shipping:** Shipping is available at the Buyer's expense. We recommend **TLC Flight Nanny** for puppy transportation; however, the Buyer may choose another flight nanny or transport service at their discretion. Puppies being shipped will depart from **Tulsa International Airport (TUL)**.



The Buyer is solely responsible for all shipping arrangements, coordination, and costs associated with flight nannies or transport services. **Responsibility for the puppy transfers to the Buyer at the time the puppy is released to the Buyer or to the Buyer's designated flight nanny or transport service.**

#### **4. CONDITION OF SALE**

Puppy is sold AS IS except as specifically stated in this Agreement. Puppy has received age-appropriate vaccinations and deworming and appears healthy at time of transfer.

Buyer is encouraged to have puppy examined by a licensed veterinarian within 72 hours of receipt.

#### **5. AKC REGISTRATION**

Puppy is sold with AKC Limited Registration only.

No breeding rights are granted. Breeding this dog voids all health guarantees and this Agreement.

#### **6. MICROCHIP & RECOVERY POLICY**

Puppy is microchipped prior to leaving Breeder.

Buyer agrees to list Breeder as secondary contact on microchip registration for the life of the dog.

If Buyer cannot be reached within 24 hours after recovery, Breeder reserves the right to retrieve and safeguard the dog.

#### **7. RETURN & RIGHT OF FIRST REFUSAL**

If Buyer is unable or unwilling to keep the dog at any time, Buyer must notify Breeder immediately.

Breeder will accept the dog back at any age. No refunds will be given.

Dog may not be surrendered to a shelter, rescue, or third party without Breeder's written consent.



## **8. HEALTH GUARANTEE**

This puppy is guaranteed until the dog's first birthday against fatal or life-altering congenital defects affecting major organ systems.

### **Conditions:**

- Buyer must notify Breeder within two (2) business days of diagnosis.
- Written documentation from a licensed veterinarian is required.
- In the event of death, a necropsy at Buyer's expense is required.

### **Remedy:**

- Remedy is replacement puppy only.
- No refunds or reimbursement of veterinary expenses.
- Replacement puppy will be of comparable quality and provided when available.
- Buyer is responsible for transportation costs.

### **Exclusions:**

This guarantee does not cover injuries, parasites, infectious diseases after 48 hours, hernias, cherry eye, entropion, undescended testicles, allergies, autoimmune disorders, Grade 1 or 2 heart murmurs, or illnesses contracted after leaving Breeder's care.

## **9. LIMITATION OF LIABILITY**

Breeder is not responsible for veterinary expenses, injuries, or accidents occurring after transfer.

Liability is limited to the remedies stated in this Agreement.

## **10. GOVERNING LAW**

This Agreement shall be governed by and interpreted under the laws of the State of Oklahoma.

Venue for any legal action shall be in Oklahoma.
